The Company has been made aware that the aforementioned share purchase was executed in several tranches over a period time ("Transactions") and, due to extended settlement terms offered by Mr Breivik's retail broker, his broker undertook regular same-day sales and purchases on Mr Breivik's account ("Funding Trades"), relevant details of which were not disclosed at that time. The Funding Trades (which on a net basis, did not change Mr Breivik's total interests in the Company's Shares from time to time) and the Transactions are detailed in the schedules below.

Mr Breivik's current interest in the share capital of the Company remains, as announced on 22 January 2024.
